WORK IN PROGRESS

Inducing Wonder (Book Project – initial interest from Harvard University Press)

We typically experience wonder at new, extraordinary sights. But we can also be made to feel wonder at quite ordinary things: chairs, toes, a blue sky, local customs, everyday assumptions, etc. This book project examines the nature, causes, and subversive power of such alienated experiences of the everyday.

Anger and Remorse (Draft)

We know that remorse, on the part of offenders, has a powerful capacity to abate anger, on the part of victims. This suggests that anger is a desire for recognition, not revenge. It also suggests that anger seeks the satisfaction of remorse itself.

On Falling Short (Draft)

Many of us make easy peace with moral imperfection. In what sense do we "accept" our own moral shortcomings, though? And is it ever right to do so?
